# A letter from the Co-Chairs

Dear RAN members, reentry advocates, and returning citizen neighbors:

As Co-Chairs of the DC Reentry Action Network (RAN), we are extremely proud of all RAN accomplished in 2019. RAN started off as a coalition aspiring to serve as a collective voice for reentry in the District, and thanks to the tenacity of our leadership, passion of our members, and support of the community, RAN has become a powerful leader on reentry issues in the city.

This past year alone RAN released a letter on the halfway house contracting situation in the District, for the first time ever taking a public position on the issue and supporting CORE DC. The letter was sent to the Federal Bureau of Prisons, the Mayor, DC Council and relevant Advisory Neighborhood Commissioners. RAN also won increased District funding for community-based reentry service providers to serve their clients.

In addition to our advocacy work, RAN organized two trainings. In March, RAN hosted a first-of-its-kind comprehensive communications training, where RAN member organizations and their returning citizen clients were taught the tools to use their personal experience to educate policy decision makers about the challenges and successes of DC's returning citizens. In June, RAN was awarded and held a Substance Abuse and Mental Health Services Administration (SAMHSA) Trauma-Informed Care for Justice-Involved People Train-the-Trainer event, where participants received SAMHSA certifications in trauma-informed care training. Altogether, 70 people participated in these trainings.

As 2020 begins to ramp up, we look forward to the future of RAN's work together and the ways in which the coalition can be of service to, and amplify the voices of, our returning citizen neighbors.

## In 2019 RAN:

- Received the Substance Abuse and Mental Health Services Administration (SAMHSA) GAINS Center's Trauma-Informed Care for Justice-Involved People Train-the-Trainer Event;
- Planned and organized a first-of-its-kind comprehensive communications training for RAN member organizations and their returning citizen clients;
- Had a record number of reentry service providers and returning citizens testify at the OVSJG Budget Oversight Hearing;
- Successfully advocated for an additional \$700,000 in funding for reentry services in the FY20 budget;
- Added four new members: Legal Aid Society DC, DC Project Connect, Criminon New Life DC, and So Others Might Eat (SOME);
- Held elections for the Membership & Governance Committee Chair, Returning Citizen Representative, and one of the Co-Chair positions;
- Developed and implemented branding for RAN, including a logo;
- Hired the first RAN returning citizen intern Tyrone Hall;
- And released a statement on the halfway house situation in the District, coming out in support of CORE DC and demanding a new halfway house in DC.
